Major Changes for 2018-2019 - Food Show & Food Challenge

- The theme for 2018-2019 Food Show is **Restaurant Re-Creations**. All recipes should reflect this theme.
- FOOD SHOW:
 - <u>Top three</u> in each age division will advance to District competition.
 - All age divisions will use Texas 4-H Food Show entry materials.
 - Senior age division contestants may not enter the same recipe if they already qualified with it at Texas 4-H Food Show in previous year(s).
 - Categories are now consistent with Food Challenge (Nutritious Snacks, Main Dish, Fruit & Vegetables, Breads & Cereals).
- FOOD CHALLENGE:
 - <u>Two teams</u> from each age division will advance to District competition.
- ALL participants will be allowed to participate in **BOTH** Food Show and Food Challenge!

All Food Show & Food Challenge contestants must register online via 4-H CONNECT. This can be done anytime between November 1 and December 7 for a \$10.00 contest management fee charged per individual and a \$5 registration fee per contest. A late fee of \$25.00 will be assessed for registrations between December 8 and December 14 in addition to the management and registration fees. **Please note that registration deadlines are earlier than in the past because the District Office is closed for Winter Break from December 21, 2018 – January 1, 2019.**

This memo will serve as your authorization to travel to D11 Food Show and Food Challenge charging expenses to your regular monthly travel allowance.
